I remember Elena Alexandrovna taught us how to prepare all kinds of budgets i.e. (sales budget, purchases budget, production budget, fixed assets budget and master Budget etc) using microsoft Excel. Apart from the Excel, the Government of Ghana use a software called GIFMIS (Generated Integrated Financial

Management Information System) which is almost similar. I can say that what Kubsu taught us has been helpful. Another one is the application of the theories of Public Private Partnership (PPP) by Elena Votchenko. Before the Government undertake any project with partnership, we check if the project is viable and cost effective by comparing budgeting with actual cost.
