

CONSENT

to the processing of personal data of an individual for the purpose of studying at Pre-university course program

I hereby give my consent to the Federal State Budgetary Educational Institution of Higher Education "Kuban State University" (hereinafter referred to as Kuban State University) (350040, Krasnodar, Stavropolskaya St., 149) for processing both using automation tools and without using such tools, including the collection, recording, systematization, accumulation, storage, clarification (updating, changing), extraction, use, transfer (distribution, provision, access), depersonalization, blocking, deletion, destruction) of my personal data, which include: 1. Data of the main identity document (passport data): last name, first name, patronymic; Date and place of birth; citizenship (region of residence); series and number of the passport; by whom and when issued; floor; address of the place of residence (registration), including a photocopy of this document (main page and registration page);

2. Biometric data (photo to ensure personal identification, registration of the student's personal file);

3. Contact details: telephone (mobile, home, work), e-mail address;

4. Information about education: data of the educational document / educational document and qualifications, academic degree, academic title, including photocopies of these documents, data on the specialty, information on foreign language proficiency;

5. Place of work, position;

6. Data of other documents, which, taking into account the specifics of training and in accordance with the legislation of the Russian Federation, must be presented by me upon admission to training or in the process of training;

7. Other information indicated by me in the application for enrolling me in the number of students in the study group for training in an additional educational program, information received as a result of my submission of documents upon admission to study and (or) in the process of studying at the Kuban State University, other information about me necessary for the Kuban State University to correctly document the legal relationship between me and the Kuban State University.

I agree that my personal data - last name, first name, patronymic, field of study, additional educational program, group may be included in public sources of personal data of the Kuban State University.

I am aware that:

1. Kuban State University processes my personal data in order to: ensure compliance with the Federal Law "On Personal Data", the current legislation of the Russian Federation in the field of personal data protection and other regulatory legal acts; correct documentation of legal relations between me and Kuban State University, fulfillment of contractual obligations; correct execution of all technological processes for working with material media (including documents) containing personal data obtained upon admission to training, in the process of training, after completion of training (in cases provided for by the current legislation of the Russian Federation); providing my education; quality control of my training; assistance in providing employment and training; providing information to state bodies and institutions of the Russian Federation in the manner prescribed by the current legislation of the Russian Federation; ensuring the provision of social guarantees to me, provided for by the current legislation of the Russian Federation; ensuring guarantees and security in accordance with the requirements of the law; ensuring the safety of the property of the Kuban State University; use in managerial, administrative and other activities of the Kuban State University not prohibited by law.

2. The processing of personal data includes the implementation of any actions (operations) in relation to my personal data that are necessary to achieve the above goals, including (without

limitation) collection, recording, systematization, accumulation, storage, clarification (updating, changing), extraction, use, transfer (including transfer to third parties - institutions and organizations that, in accordance with the Federal Law "On Personal Data", Kuban State University may entrust the processing of personal data, or is obliged to provide personal data in accordance with the current legislation of the Russian Federation) , depersonalization, blocking, deletion, destruction, cross-border transfer of personal data (in the case of my sending abroad) to a foreign partner university (an organization that has a contractual or partnership relationship with Kuban State University) in order to receive an invitation and further apply for a visa, as well as realizing exclusion of any other actions with my personal data provided for by the current legislation of the Russian Federation.

3. I have the right to free access to my personal data processed by the Kuban State University, their withdrawal (in whole or in part) or blocking (on a personal request).

4. Consent may be withdrawn by a written notification of the Kuban State University at the legal address.

5. Upon enrolling in additional educational programs at the Kuban State University, I am familiar with the “Regulations on the procedure for organizing and carrying out work on the processing and protection of personal data processed in personal data information systems”, “Personal data processing policy of the Federal State Budgetary Educational Institution of Higher Education “KubSU”, rights and obligations in the field of personal data protection.

I authorize the processing of my personal data in an automated and non-automated way from the moment of signing the consent during the entire period of my studies at the Kuban State University, and after its completion - to store in an archive, the storage periods of which are established by the current legislation of the Russian Federation.

I confirm that all of my personal data listed in the Consent was received by Kuban State University personally from me and is reliable. I undertake to promptly notify the Kuban State University of each change in my personal data. I do not object to my personal data being available to employees of the structural units of the Kuban State University implementing additional educational programs.

This Consent is valid from the moment of its signing during the entire period of my studies at the Kuban State University and the terms established by the current legislation. I confirm that by giving such Consent, I am acting of my own will and in my own interests.
